	of \$36K. Waiting for the accountant to confirm.	
	• Officials and timekeepers that was significantly over (\$14K), after	
	investigation it was identified that:	
	 In December, all referees and timekeepers were double 	
	paid (invoice from Referee-in Chief was untimely sent	
	through twice for December, late in January - resulting in	
	\$8K overpayment). There is a new process in place to do a	
	double check to ensure this doesn't happen again.	
	 There were two U23 teams, however only one was 	
	budgeted for one, resulting in \$6K more cost

	allocated for development	
	 Registration is increasing this year, tryout fees and rep 	
	fees also increasing. Note there hasn't been a fee increase	
	in 7 years, but we have to this year due to costs continuing	
	to go up in a lot of areas, including:

	 We only have one sponsor (Pro Hockey Life), so we will 	
	be looking for new sponsors this year to support our
