Once registration is received, if a player decides not to play for any reason, they may request a refund.

If a player decides not to play before 15 days before the start of the season as posted on the website a refund of \$150 will be provided.

After 15 days before the start of the season, and before 15 days after the start of the season, the league will refund \$100 of your registration fee.

No refunds will be offered after t15 days after the start of the season.

Team Jerseys are to be returned to the league after the final game has been played.

All parents agree to pay \$35 if they do not return their team jersey. This charge will be sent to the parent within two weeks after the season ends by email and will be payable by e-transfer. If the team jersey is returned, the cost will be waived.

Please ensure your player can play before registering.

Consumer Protection Law

Where the *Consumer Protection Act*, or any other consumer protection legislation in your jurisdiction applies and cannot be excluded, these Terms and Conditions will not limit your legal rights and remedies under that legislation. These Terms and Conditions will be read subject to the mandatory provisions of that legislation. If there is a conflict between these Terms and Conditions and that legislation, the mandatory provisions of the legislation will apply.

Limitation of Liability
